# Canon (UK) Spring 2015 Cashback promotion Terms & Conditions

# 1. PROMOTIONAL PRODUCTS, PROMOTIONAL PERIOD AND PARTICIPANTS

- 1.1. This promotion is only available on purchases made of any of the products listed below/attached (the "Promotional Products") within the United Kingdom ("UK") or Republic of Ireland ("ROI") from a UK or ROI retailer between Thursday 5th March 2015 and Wednesday 6th May 2015 inclusive (the "Promotional Period"). Promotional Products can be sold as a camera body only or part of a lens kit or bundle but only ONE claim can be made per kit or bundle. So if a kit includes two Promotional Products, the Participant will need to pick one product against which to make a claim. Purchases must be genuine purchases for cash or its equivalent.
- 1.2. All Participants must be aged 18 or over and must be resident in the EU ("**Participant**").
- 1.3. All Participants are deemed to have agreed to be bound by these terms and conditions.
- 1.4. All products must be purchased within the UK or ROI from a UK or ROI retailer, (except from the Dixons' Travel stores, which are excluded from this promotion) and must have been supplied and distributed to retailers by Canon UK Ltd ("Canon") or Canon group companies located in the European Economic Area or Switzerland (EEA). Internet stores must have a ".co.uk" or "ie" web address and/or display a registered/postal address in the UK or ROI.
- 1.5. All Promotional Products must be new and genuine Canon products. Purchases of second hand, refurbished or reconditioned products, or products which are counterfeit or infringe the intellectual property rights of the Canon group of companies in any way (for example, including but not limited to parallel or "grey" products) will not qualify under this promotion. #### 2. HOW TO PARTICIPATE

- 2.1.To enter the promotion, the Participant must purchase a Promotional Product within the UK or ROI from a UK or ROI retailer during the Promotional Period AND submit a valid claim online between 00.01 on Thursday 5<sup>th</sup> March 2015 and midnight on Friday 5<sup>th</sup> June 2015.
- 2.2. Claims must be submitted by fully and correctly completing (including specifying a valid EEA product serial number) a claim form online, at www.canon.co.uk/springcashback or www.canon.ie/springcashback. Participants will need to scan, upload and attach to the online claim form a copy of their till receipt, or order confirmation for internet purchases. - 2.3. The Promotional Products are subject to availability while stocks last. Canon will not be liable for the failure of retailers to fulfill orders of Promotional Products during the Promotional Period.
- 2.4. Canon will not process any claims received after the closing date for receipt of claims of **midnight on Friday 5<sup>th</sup> June 2015**. Canon will not process claims which are in its opinion incomplete or illegible. Canon will not be responsible for claims delayed or not successfully received.
- 2.5. Only one claim per Promotional Product purchased may be made.
- 2.6. Claims by businesses or individuals who make bulk purchases (being more than 10 Promotional Products during the Promotional Period, other than where the relevant products are comprised in kits or bundles as described in clause 1.1) will not be eligible to enter this Promotion.

## 3. CASHBACK

- 3.1. Participants will receive Cashback in the amounts shown for purchases of Promotional Products.
- 3.2. Upon receipt and verification of the claim, Canon will arrange for a direct BACS transfer payment to the Participant's bank account. No alternative arrangement will be entered into and no cash or cheque will be provided.
- 3.3. Canon will endeavor to transfer via BACS within 28 days of receipt of a complete and valid claim.
- 3.4. Where a Participant fails to select one of the currencies offered on the claim form, one may be allocated at Canon's absolute discretion.
- 3.5. Only one BACS payment will be issued per valid claim.
- 3.6. If you are UK VAT registered and you receive a cashback, it may reduce the taxable value of your purchase and so you may need to reduce your input tax accordingly.
