2. This Brother UK Ltd (BUK) promotion is valid only on the above Qualifying Products which must be purchased from a Brother Authorised Dealer within the United Kingdom, details of which are available by telephoning 0333 777 4444.
3. This promotion is only valid on direct from manufacturer new products or AG products sourced as in Clause 2. Refurbished machines, second-hand machines, any machine acquired from commercial leasing, hire purchase, URN supported business or similar arrangements and any machines sourced via the internet from a company not registered in the United Kingdom do not qualify. In addition any machines acquired free of charge as part of any promotion supported direct or indirect by BUK are also ineligible. In all circumstances it is the responsibility of the claimant to check the validity of supply.
