

Canon (UK) Summer 2016 Cashback promotion Terms & Conditions

1. PROMOTIONAL PRODUCTS, PARTICIPATING RETAILERS, PROMOTIONAL PERIOD AND PARTICIPANTS

- 1.1. This promotion is only available on purchases made of any of the products listed below/attached (the "**Promotional Products**") within the United Kingdom ("**UK**") or Republic of Ireland ("**ROI**") from one of our **Participating Retailers** between **Thursday 19th May 2016 and Wednesday 31st August 2016** inclusive (the "**Promotional Period**"). All other products and retailers are excluded. Products purchased on the Canon e-store (store.canon.co.uk) have cashback automatically applied to the price and are not eligible for additional cashback via the redemption process. Promotional Products can be sold as a camera body only or part of a lens kit or bundle **but only ONE claim can be made per kit or bundle**. So if a kit includes two Promotional Products, the Participant will need to pick one product against which to make a claim. Purchases must be genuine purchases for cash or its equivalent.
- 1.2. All Participants must be aged 18 or over and must be resident in the European Economic Area or Switzerland ("**EEA**") ("**Participant**").
- 1.3. All Participants are deemed to have agreed to be bound by these terms and conditions.
- 1.4. Purchases of second hand, refurbished or reconditioned products, or products which are counterfeit or infringe the intellectual property rights of the Canon group of companies in any way (for example, including but not limited to parallel or "grey" products) will not qualify under this promotion. 2. HOW TO PARTICIPATE

- 2.1. To enter the cashback promotion, the Participant must purchase a Promotional Product from a Participating Retailer during the Promotional Period AND submit a valid claim online between 00.00 on Thursday 19th May 2016 and **midnight on Friday 30th September 2016**.
- 2.2. Claims must be submitted by fully and correctly completing (including specifying a valid EEA product serial number) a claim form online, at www.canon.co.uk/summercashback16 or www.canon.ie/summercashback16. Participants will need to scan, upload and attach to the online claim form a copy of their receipt, or order confirmation for internet purchases. Participants will then receive an email confirming that their claim has been received. If you do not receive a confirmation email within 24 hours of processing your claim, or do not have access to a computer, please contact our **Claim Hotline on 0800 044 3251**.

- 2.3. The Promotional Products are subject to availability while stocks last. Canon will not be liable for the failure of retailers to fulfill orders of Promotional Products during the Promotional Period.
- 2.4. Canon will not process any claims received after the closing date for receipt of claims of **midnight on Friday 30th September 2016**. Canon will not process claims which are in its opinion incomplete or illegible. Canon will not be responsible for claims delayed or not successfully received.
- 2.5. Only one claim per Promotional Product purchased may be made.
- 2.6. Claims by businesses or individuals who make bulk purchases (being more than 10 Promotional Products during the Promotional Period, other than where the relevant products are comprised in kits or bundles as described in clause 1.1) will not be eligible to enter this Promotion.
- 2.7. This promotion cannot be redeemed in conjunction with any other promotion.

3. CASHBACK

- 3.1. Participants will receive Cashback in the amounts shown for purchases of Promotional Products.
- 3.2. Upon receipt and verification of the claim, Canon will arrange for a direct BACS transfer payment to the Participant's bank account. No alternative arrangement will be entered into and no cash or cheque will be provided.
- 3.3. Canon will endeavor to transfer via BACS within 28 days of receipt of a complete and valid claim.
- 3.4. Only one BACS payment will be issued per valid claim.
- 3.5. If you are UK VAT registered and you receive a cashback, it may reduce the taxable value of your purchase and so you may need to reduce your input tax accordingly.

4. PRIZE DRAW

- 4.1. To enter the prize draw Participants must sign up to receive email communications from Canon in addition to meeting the criteria in clause 1 above.
- 4.2. The prizes are 3 x trips for two to the iconic city of Dubai, UAE. One member of each party must be aged 18 or over
- 4.3. The prize comprises a three-night break for two to Dubai staying at a 4* hotel sharing a double or twin room on a bed and breakfast basis. Included within the prize are the following: return economy flights from London, Dublin or Manchester, airport transfers, 4 x 4 desert safari, city tour, high tea at Atmosphere (at the Burj Kalifa) and travel insurance (which does not cover pre-existing medical conditions).

- 4.7. The prize trips can be taken up until 30 September 2017 excluding travel over Christmas, Easter, bank holidays and the Dubai World Cup. All travel must be completed by 30 September 2017.
- 4.8. All holiday locations and dates are subject to availability. Travel will be subject to flight and hotel availability at the date of booking the trip. Winners should notify the Promoter at least six weeks in advance of his/her preferred dates for taking the trip.
- 4.9. The Prize is non-transferable and no cash or credit alternatives will be substituted for the prize on offer. In the event that the prize offered is unavailable due to circumstances beyond our control, Canon reserves the right to offer an alternative prize of equal or greater value.
- 4.10. All travel arrangements offered are at the discretion of the 3rd party agent. Any requests relating to airport, airlines or hotels cannot be guaranteed. Passports and visas are the responsibility and at the cost of Winners.
