3. The Promotion is open to legal residents of the United Kingdom only who are aged 18 or over. For the avoidance of doubt the date on the proof of purchase counts as day one. If claims are submitted before or after this claim window they will be deemed invalid and rejected.
9. When completing the claim form customers must upload proof of purchase to the Promotional Website. The proof of purchase must be the selected Reseller's invoice or a valid VAT receipt and must clearly show the Qualifying Product(s), the purchase price, the retailer and the date of purchase.
10. Once the claim has been received and approved, the participant will receive confirmation of receipt of the claim form by email ("Confirmation email") stating whether or not the claim for cashback has been successful. Cashback is paid via bank transfer.
